In Focus

European Affairs activities of the MP's in the 9th term of the Croatian Parliament

In the 9th term, the Parliament continued to participate in the European legislative process in accordance with the Law on Cooperation between the Croatian Parliament and the Government of the Republic of Croatia in the European Affairs and its Rules of Procedure and the powers of national parliaments arising from European Union law.

Parliament regularly monitored the work of the Government by discussing reports from all European Council meetings. The Committee on European Affairs and the competent working bodies considered individual reports from the meetings of the Council of the European Union as well as the positions of the Republic of Croatia on individual draft acts, and in three cases the Committee on European Affairs participated in the process of proposing candidates for EU institutions.

Interparliamentary cooperation in the European Union is also a form of the influence of national parliaments on the decision-making process at the European level, as a result of which members of the Croatian Parliament in the 9th term participated in 156 meetings.

As the national parliament of an EU member state, the Croatian Parliament is the host of the parliamentary dimension of the Croatian Presidency of the Council from 1 January to 30 June 2020.

The calendar of the parliamentary dimension of the Croatian presidency provided for the holding of five inter-parliamentary conferences and meetings (four in Zagreb and one in Brussels). However, due to the circumstances of the Covid-19 pandemic and the cancellation of international activities in the European Union institutions and member states, the Croatian Parliament organized only three conferences.

However, despite the cancellation of the 6th meeting of the Europol Joint Parliamentary Oversight Group (JPSG), the Croatian Parliament, ie the Committee on Internal Policy and National Security, decided, in its capacity as co-chair of the Europol Joint Parliamentary Oversight Group, to monitor the activities of Europol in writing, in accordance with the provisions of Art. 12 and 51 of the Europol Regulation.

In relation to the cancelled plenary meeting of COSAC, the Committee on European Affairs, in cooperation with the members of the Troika, conducted the procedure of adopting the 33rd Bi-annual report of COSAC. Additionally, European Affairs Committee organised Extraordinary Meeting of the Chairpersons of COSAC via videoconference on 16 June 2020.

Below are statistical data on the activities of the Croatian Parliament arising from the membership of the Republic of Croatia in the European Union in the 9th term from 14 October 2016 to 18 May 2020.

Activities of the Croatian Parliament in the Decision-Making Process

Activities of the European Affairs Committee

European Affairs Committee held two sessions in May 2020 as follows:

- On its 58th session held on 8 May 2020, European Affairs Committee adopted Work Programme for the consideration of the positions of the Republic of Croatia for 2020. Additionally, Committee adopted Report on its activities for 2019 and submitted it to the plenary for approval.
- On its 59th session held on 15 May 2020, joint session with Finance and Central Budget Committee, European Affairs Committee debated on National Reform Programme 2020 and Convergence Programme 2020 2021.

Application of EU law

In May, Croatian Parliament enacted 7 laws in the process of implementation of European law.

EU documents Forwarded Directly to the Croatian Parliament

According to the Protocol (no 1) on the Role of the National Parliaments in the European Union, all draft laws and communications shall be forwarded directly to the national parliaments.

The Croatian Parliament publishes on a daily basis the EU documents received, along with the information on: document number, adoption procedure, transmission date and subsidiarity deadline.

In May 2020, EU institutions forwarded to the Croatian Parliament <u>59 documents</u>: 37 draft laws and 22 communications and other non-binding documents.

Inter-parliamentary Cooperation in the European Union

Inter-parliamentary cooperation in the European Union encompasses the cooperation between the European Parliament and the national parliaments and the cooperation among the national parliaments in the frame of the parliamentary dimension of the Council Presidency.

All conferences, meetings and other activities that take place in the framework of inter-parliamentary cooperation in the European Union planned for May and June are not held until further notice due to the situation related to the COVID-19 pandemic.

Activities of the Croatian Parliament in the Conference of Parliamentary Committees for Union Affairs of the European Union (COSAC)

Following the decision to cancel the LXIII Conference of Parliamentary Committees for Union Affairs of the European Union (COSAC) due to the COVID-19 pandemic and the impacts of the earthquake that hit Zagreb, the Chairman of the European Affairs Committee Domagoj Ivan Milošević, acting as the chair of the COSAC, proposed that the Presidential Troika meet by video conference to exchange views on the further course of action of the COSAC as a forum for interparliamentary cooperation in light of the current crisis caused by the coronavirus.

The Presidential Troika held the extraordinary meeting on 20 May and decided that an Extraordinary Meeting of the Chairpersons of the Committees for Union Affairs would be held via video conference. The topics to discuss will be the common European response to the COVID -19 outbreak and its impacts on the Multiannual Financial Framework 2021-2027 and the Conference on the Future of Europe. The main points of the meeting will be presented to the Commission and the Council.

The meeting is held on 16 June 2020 from 09.00 to 12.00 hrs CET via the Cisco Webex platform. All documents are available here and on IPEX. The meeting is open to the public by means of web streaming.

Activities of the Croatian Parliament in the Joint Parliamentary Scrutiny Group on Europol

The 6th Meeting of the Joint Parliamentary Scrutiny Group on Europol is cancelled due to the situation caused by the COVID-29 pandemic and the impacts of the earthquake that affected Zagreb on 22 March 2020.

Having consulted with the other members of the Presidential Troika, the Co-Chairs of the Joint Parliamentary Scrutiny Group on Europol Ranko Ostojić and Juan Fernando López Aguilar decided to cancel the JPSG meeting due to the COVID-19 pandemic and the impacts of the earthquake in Zagreb.

In order to ensure the continuity of the JPSG activities during the coronavirus crisis, an electronic exchange of information has been proposed between JPSG members and the Europol Executive Director, the Chairperson of the Europol Management Board, the European Data Protection Supervisor and the Chair of the Europol Cooperation Committee, who are invited, as keynote speakers of the cancelled meeting, to submit their written contributions by 1 June 2020.

JPSG members are also invited to submit their written contributions and questions, following the contributions of the keynote speakers, if they are interested by 15 June 2020. A consolidated answer will be provided to all contributions and questions by 30 June 2020.

All contributions will be distributed by e-mail and published here and on IPEX.
