


PRIJAVA ZA JAVNI POZIV

VI. Information about availability to serve the CPT effectively

- In period between 1998 and 2002 I was delegate at Council of Europe, Torture Prevention Commission (CPT) and have acquired an experience and insight into that field of work at which I am very interested in. During that period I had 14 visits as CPT member. After the end of my mandate I remained available to CPT as expert medical witness. Due to numerous obligations in identification process of Homeland War victims, expert witness testimonies for International Criminal Tribunal for the Former Yugoslavia as well in every day work at the

Department of Forensic Medicine and at School of Medicine I was not in position to accept new mandate for CPT. In addition, in the year 2008 I have become the head of the Department of Forensic Medicine and Criminology, Medical School University of Zagreb.

In year 2014 I was retired from my position at School of Medicine and Department of Forensic Medicine and Criminology. I was elected at the Council of Europe Torture Prevention Commission (CPT) 2014 – November 2017. And first time reelected from 2017-2021. Now I have much more free time and I will be able to commit myself to missions of CPT and will be able to serve CPT effectively and with full use of my prior experience.

VI. Informations de disponibilité pour un service efficace au CPT

- Entre 1998 et 2002, j'ai été délégué au Conseil de l'Europe, au Comité européen pour la prévention de la torture (CPT), et j'ai acquis une expérience et une compréhension dans ce domaine de travail qui m'intéresse beaucoup. Pendant cette période-là, j'ai eu 14 visites en tant que membre du CI. Après la fin de mon mandat, je suis resté à la disposition du CPT

en tant que témoin médical professionnel. En raison de nombreuses obligations dans le processus d'identification des victimes de la guerre de patrie, témoignages d'experts du Tribunal pénal international pour l'ex-Yougoslavie, ainsi que dans mon travail quotidien à l'Institut de Médecine Légale et à la Faculté de Médecine, je n'ai pas pu accepter un nouveau mandat pour le CPT. En outre, en 2008, je suis devenu chef du Département de Médecine Légale et de Criminologie de la Faculté de Médecine de l'Université de Zagreb.

- En 2014, j'ai été démis de mes fonctions de la Faculté de Médecine et du Département de Médecine Légale et Criminologie. J'ai été élu au Comité européen pour la prévention de la torture (CPT) du Conseil de l'Europe 2014- novembre 2017. Réélu pour la première fois 2017-2021. J'ai maintenant beaucoup plus de temps libre et je pourrai me consacrer aux missions du CPT, je serai en mesure de servir le CPT efficacement et de tirer pleinement de mes expériences antérieures.
